Document list for Malta Study Visa: -

1. Original attested (apostilled) copies of the below academic documents (native language & in English).

For Undergraduate Applicants: -

- School leaving certificate and Mark sheet
- English Language Certificate like IELTS, PTE etc.

For Postgraduate Applicants: -

- Bachelor's degree and Transcripts
- School leaving certificate and Mark Sheet
- English Language Certificate like IELTS, PTE etc.
- 2. Original and Photocopy of the passport (Front and back page)
- 3. One recent Passport size photograph in colour with white background (3.5cm by 4.5cm).
- **4. Overseas Health Insurance with cover 30,000 euros.** You can also buy it from an Indian company like Bajaj, TATA etc.
- **5.** Original attested Bank Letter & Bank Statement of saving account or Fixed Deposit verifying that the student or student's sponsor has sufficient funds to cover the tuition fees and living expenses while studying at Cyprus (13000 to 15000 Euros which should be 3 to 6 months old). <u>Sometimes embassy asks</u> for source of money as well.

It should include the below:

- Name of the account holder
- Account number
- Balance of the account.

<u>Note</u>, student can also alternatively show education loan but should be fully sanctioned or preferably disbursed in the bank account.

- **6. Payment receipt of first tuition fee deposit** as per university requirement.
- **7. Proof of Accommodation.** (University usually helps with it by providing/arranging the accommodation or its proof)
- **8. Offer/Admission Letter** from the Educational Institute in Malta.
- **9. An Affidavit of Sponsorship and income proofs** of sponsor like last 3 years ITRs or other acceptable income proofs.
- 10. **Other Documents:** includes statement of purpose, cover letter, and a no objection certificate from parents (if a minor).

IMPORTANT NOTES: -

- 1. Generally, the academic documents need to be attested with an 'Apostille' stamp/seal.
- 2. For education loan, it should be availed from an acceptable financial institution, be in principle or conditional and should be Fully sanctioned. Collateral security-Immovable property along with valuation report of the property and collateral security should belong to immediate family members
- 3. Visa TAT is normally up to 4-6 weeks and the entire process can take up to 3-4 months. Once the visa is approved, a confirmed return flight ticket may be requested prior to visa being issued.
- 4. There is usually a deadline for applying the visa like ending July for September/October intake, so make sure you submit the application within the deadline.
- 5. Note that your appointment for Student visa must be booked by the Educational Institution you are applying with.
- 6. The standard Visa fee is 100 euros and extended student visa fees is 150 euros for Malta based on urgency of your timeline.
